

AN ORDINANCE APPROVING A RENEWAL EMPLOYMENT CONTRACT  
BETWEEN THE CITY OF STOW AND BONNIE J. EMAHISER AS CLERK OF  
COUNCIL FOR THE CITY OF STOW AND ESTABLISHING COMPENSATION.

WHEREAS, Article III of the employment contract between Bonnie J. Emahiser and the City of Stow provides that this Agreement may be renewed or extended by the mutual agreement of the parties hereto prior to the Expiration Date, provided that such renewal or extension has first been approved by Stow City Council; and

WHEREAS, Bonnie J. Emahiser is a valued employee of the City of Stow, with experience and expertise that benefits the City of Stow in the present performance of her duties as a contract City employee; and

WHEREAS, the City of Stow desires to retain Bonnie J. Emahiser's experience and expertise for the benefit of the City of Stow and its residents; and

WHEREAS, Bonnie J. Emahiser desires to continue to provide services to the City of Stow as a full-time contractual employee;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STOW,  
COUNTY OF SUMMIT AND STATE OF OHIO:

SECTION 1. That the Mayor be, and she hereby is, authorized to make and enter into a renewal employment contract with Bonnie J. Emahiser as Clerk of Council for the City of Stow, for the term of February 1, 2017 through January 31, 2018.


SECTION 2. That the compensation and benefits to be paid to Bonnie J. Emahiser as a contract employee are hereby authorized in accordance with the employment contract as renewed and attached hereto and made a part of this ordinance by reference.



SECTION 4. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees or subcommittees that resulted in those formal actions were in meetings open to the public in compliance with the law

SECTION 5. This Ordinance was adopted pursuant to Section 4.11, Charter, and shall take effect thirty (30) days after its adoption by Council and approval by the Mayor, otherwise, at the earliest period allowed by law.



CONTRACTUAL AGREEMENT RENEWAL

The City of Stow, Ohio, an Ohio Municipal Corporation, (hereafter "City"), hereby enters into a contract renewal with Bonnie J. Emahiser this \_\_\_\_\_ day of \_\_\_\_\_, 2016. Collectively, the City and Bonnie J. Emahiser may be referred to as the "parties" hereafter. This agreement shall renew each and every term of the agreement entered into as of February 1, 2009 unless specifically changed herein. The parties understand that this renewal is subject to the approval of Stow City Council.

WHEREAS, the employment contract entered into as of February 1, 2009, between the City of Stow, an Ohio Municipal Corporation, (the "City"), and Bonnie J. Emahiser provides in Section III, Term, paragraph 2, that:

"This Agreement may be renewed or extended by the mutual agreement of the parties hereto prior to the Expiration Date, provided that such renewal or extension has first been approved by Stow City Council."

WHEREAS, the parties to the original employment contract dated February 1, 2009, i.e., the City of Stow and Bonnie J. Emahiser, desire to renew it for a one-year period and such original contract expires at midnight on the 31<sup>st</sup> day of January 2017.

NOW, THEREFORE, the parties agree as follows:

1. The employment contract between the City of Stow and Bonnie J. Emahiser entered into as of February 1, 2009, is hereby renewed for a one-year period. The renewed agreement will commence on February 1, 2017 and expire at midnight on the 31<sup>st</sup> day of January, 2018.
