The Organizational Meeting is the first working day of January at 8:00 p.m. (Council Chambers)
COUNCIL COMMITTEES:	Thursdays prior to regular Council Meetings – usually at 5:30 p.m. (time dependent on the number of items) – and Mondays the week of Council Meetings if a topic is determined to need an extended period of time for discussion – at 5:30 p.m. (Council Chambers)
PUBLIC HEARINGS OF COUNCIL	Thursdays prior to regular Council Meetings - usually at 5:30 p.m. - and Mondays the week of Council Meetings if a topic is determined to need an extended period of time for discussion – at 5:30 p.m. (Council Chambers)
BOARD OF CONTROL	Wednesdays at approximately 9:30 a.m. (Mayor’s Conference Room)
CEMETERY BOARD	No regular meetings (Service Building Conference Room)
CIVIL SERVICE COM.	Second Wednesday of February, May, November and August at 8:30 a.m. (Boards & Commissions Room)
PUBLIC SAFETY SERVICES COM.	No regular meetings (Mayor’s Conference Room)
INCOME TAX BOARD OF REVIEW	No regular meetings (Second Floor Meeting Room)
PARKS & RECREATION BOARD	Second Thursday of January, March, May, July & October at 6:00 p.m. (Boards & Commissions Room)
PLANNING COMMISSION	Second and Fourth Tuesdays of each month at 6:00 p.m. (Boards & Commissions Room)
STOW URBAN FORESTRY COM.	First Monday of each month at 3:30 p.m.. (Service Building Conference Room)
BOARD OF ZONING & BUILDING APPEALS	Second Monday of each month at 6:00 p.m. (Boards & Commissions Room)

COMMISSION ON DISABILITIES	Fourth Tuesday of each month at 6:30 p.m. (Boards & Commissions Room)
SENIOR CITIZENS COMMISSION	Third Tuesday of February, May, August & November at 7:00 p.m. (Stow Senior Center)
STOW COMMUNITY IMPROVEMENT CORP.	Second Thursday quarterly (March, June, September & December) at 8:00 a.m. (Council Chambers)
