

AN ORDINANCE AMENDING ORDINANCE NO. 2013-186, WHICH AUTHORIZED THE MAYOR TO MAKE AND ENTER INTO A SEVEN –YEAR CONTRACT WITH SOUTH EAST HARLEY DAVIDSON COMPANY, A SOLE SOURCE PROVIDER, FOR THE RENTAL OF SIXTY-TWO (62) 2014 CLUB CAR PRECEDENT GOLF CARS, WITHOUT THE NECESSITY OF PUBLIC BIDS, TO INCREASE THE NUMBER OF CARS TO SIXTY-SIX (66), TO INCREASE THE LIMIT OF THE EXPENDITURES FOR THE REMAINING YEARS OF THE CONTRACT AND DECLARING AN EMERGENCY.

WHEREAS, in 2013, the Council of the City of Stow authorized the Mayor to enter into a seven-year agreement with South East Harley Davidson Company for the rental of sixty-two (62) 2014 Club Car Precedent Golf Cars under authority of Sections 173.07(a)(1)G and 173.07(b(1)A; and

WHEREAS, the Service Director has requested to increase the number of cars to sixty-six (66) and to increase the limit of the expenditures for the rental of said cars for the remainder of the contract; and

WHEREAS, this Council feels it fitting and appropriate to do so;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STOW, COUNTY OF SUMMIT AND STATE OF OHIO:

SECTION 1. That Ordinance No. 2013-186, particularly Section 1 thereof, which formerly read:

“SECTION 1. That the Mayor be, and she hereby is, authorized to make and enter into a contract with South East Harley Davidson Company, a sole source provider, for the rental of Sixty Two (62) 2014 Club Car Precedent golf cars.”

be, and the same is, hereby amended to read henceforth as follows:

“SECTION 1. That the Mayor be, and she hereby is, authorized to make and enter into a contract with South East Harley Davidson Company, a sole source provider, for the rental of Sixty-Six (66) 2014 Club Car Precedent golf cars for the remainder of the previously approved seven-year term.”

SECTION 2. That Ordinance No. 2013-186, particularly Section 2 thereof, which formerly read:

“SECTION 2. That the Finance Director be, and he hereby is, authorized to appropriate, encumber, and pay funds in an amount not to exceed Fifty Two Thousand Eighty and 00/100 Dollars (\$52,080.00) to South East Harley Davidson for the rental of the golf cars.

be, and the same is, hereby amended to read henceforth as follows:


“SECTION 2. That the Finance Director be, and he hereby is, authorized to appropriate, encumber, and pay funds in an amount not to exceed Fifty-Five Thousand Four Hundred Forty and 00/100 Dollars (\$55,440.00) to South East Harley Davidson for the rental of the golf cars for the remainder of the previously approved seven-year term.”

SECTION 2. That all other terms and provisions of Ordinance No. 2013-186, and relating legislation not amended herein, be, and the same are, hereby reaffirmed as if fully reappearing herein.

SECTION 3. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees and subcommittees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 4. That this ordinance was adopted pursuant to Section 4.11 Charter, and is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety in order to provide the necessary equipment when needed , and, pursuant to Section 4.13 Charter, shall take effect upon its adoption by Council and approval by the Mayor, otherwise at the earliest period allowed by law.
