

ORDINANCE NO. 2018-96

REQUESTED BY SERVICE DIRECTOR

INTRODUCED BY D'ANTONIO

AN ORDINANCE AUTHORIZING AN EXPENDITURE FOR THE PURCHASE OF A SOURCE CAPTURE EXHAUST EXTRACTION SYSTEM FOR FIRE STATION NO. 1 FROM SOLE SOURCE PROVIDER MAGNEGRIp GROUP, WITHOUT THE NECESSITY OF PUBLIC BIDS, AND DECLARING AN EMERGENCY.

WHEREAS, the Service Director has requested authorization for the purchase of a Source Capture Exhaust Extraction System for Fire Station No. 1 from sole source provider MagneGrip Group, exempt from public bidding requirements pursuant to C.O.S. 173.07(a)(1)G and 173.07(b)(1)E; and

WHEREAS, pursuant to Section 173.10, C.O.S., the total amount of the expenditure requires legislative approval by this Council;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STOW, COUNTY OF SUMMIT AND STATE OF OHIO:


SECTION 1. That the Finance Director be, and he hereby is, authorized to appropriate, encumber, and pay funds in an amount not to exceed Sixty-One Thousand Five Hundred Fourteen and 80/100 Dollars (\$61,514.80) for the purchase of a Source Capture Exhaust Extraction System to sole source provider MagneGrip Group.


SECTION 2. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees or subcommittees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 3. That this ordinance was adopted pursuant to Section 4.11 Charter, and is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety for the reason that we must meet timeline deadlines with this grant, and, pursuant to Section 4.13, Charter, shall take effect upon its adoption by Council and approval by the Mayor, otherwise at the earliest period allowed by law.


