

A RESOLUTION EXTENDING THE OFFICIAL GRATITUDE AND COMMENDATION OF THE CITIZENS OF THE CITY OF STOW TO STEVE IVANOV AND HIS FAMILY, OWNERS OF STEVE’S PROFESSIONAL DRY CLEANERS, FOR FIFTY (50) YEARS OF EXEMPLARY SERVICE TO THE CITIZENS OF STOW AND DECLARING AN EMERGENCY.

WHEREAS, Handcraft Cleaners, located in the Stow-Kent Shopping Center, was given to Steve as a wedding present in 1968; and

WHEREAS, his ex-wife ran the store while he served in the Army in Vietnam; and

WHEREAS, when he returned from Vietnam in 1970, he changed the name of the store to Steve’s; and

WHEREAS, in the 1980s, Steve’s Professional Dry Cleaners moved from the Stow-Kent Shopping Center to the Stow Plaza; and

WHEREAS, after 50 years of exemplary service, Steve Ivanov has chosen to retire; and

WHEREAS, this Council deems it fitting and appropriate to recognize the exemplary service made by Steve Ivanov and his family and to commend them for their dedication to residents of the City of Stow.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STOW, COUNTY OF SUMMIT AND STATE OF OHIO:

SECTION 1. That on behalf of the present Council, the City Administration, and all citizens of the City of Stow, Ohio, the official gratitude and appreciation of this City are hereby extended to Steve Ivanov and his family for their exemplary service to the citizens of the City of Stow for fifty (50) years. This Council declares that their service was significant and noteworthy and typifies the highest ideals of civic pride and zeal.


SECTION 2. That the Clerk of Council be, and she hereby is, authorized and directed to cause a certified copy of this enactment to be served upon Steve Ivanov and to have the same spread upon the permanent records of the City for all those who follow to emulate.

SECTION 3. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees or subcommittees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 4. That this Resolution was adopted pursuant to Section 4.11 Charter, and is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety for the reason that it is fitting and appropriate to immediately recognize the exemplary service of Steve Ivanov and his family, and pursuant to Section 4.13 Charter, shall take effect upon its adoption by Council and approval by the Mayor, otherwise at the earliest period allowed by law.
