ORDINANCE NO. 2019-28

AN ORDINANCE AMENDING ORDINANCE NO. 2012-36 AND ALL AMENDMENTS THERETO, PARTICULARLY SECTION 1 THEREOF, ENTITLED “ESTABLISHMENT, COMPOSITION AND TERM”, AND SECTION 3 THEREOF, ENTITLED “MEETINGS AND QUORUM”, TO INCREASE THE NUMBER OF COMMISSION MEMBERS ON THE STOW COMMISSION ON INCLUSION AND INCREASE THE QUORUM FOR SAID COMMISSION AND DECLARING AN EMERGENCY.

WHEREAS, in order to increase citizens’ input, Mayor Pribonic has requested that City Council increase the number of Commission Members on the Stow Commission on Inclusion; and

WHEREAS, Stow City Council wishes to honor the Mayor’s request;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STOW, COUNTY OF SUMMIT AND STATE OF OHIO:

SECTION 1. That Ordinance 2012-36 and all amendments thereto, particularly Section 1 thereof, which formerly read:

“SECTION 1. ESTABLISHMENT, COMPOSITION AND TERM.

There is hereby created a Commission on Inclusion which shall be composed of five members who are residents of the City of Stow. All appointments of the commission shall be made by the Mayor, and confirmed by City Council. Appointments shall include at least three people who live with a disability or are an immediate family member of an individual with a disability. Each member shall be appointed for a term of four years.”

be, and the same is, hereby amended to read henceforth as follows:

“SECTION 1. ESTABLISHMENT, COMPOSITION AND TERM.

There is hereby created a Commission on Inclusion which shall be composed of up to nine members who are residents of the City of Stow. All appointments of the commission shall be made by the Mayor, and confirmed by City Council. Appointments shall include at least three people who live with a disability or are an immediate family member of an individual with a disability. Each member shall be appointed for a term of four years.”

SECTION 2. That Ordinance 2012-36 and all amendments thereto, particularly Section 3 thereof, which formerly read:

“SECTION 3. MEETINGS AND QUORUM.

Three members of the commission shall constitute a quorum. The commission shall meet at least four times each year and shall be subject to call by the chairperson or any two commission members at any time.

be, and the same is hereby amended to read henceforth as follows:

“SECTION 3. MEETINGS AND QUORUM.


A majority of the members of the commission shall constitute a quorum. The commission shall meet at least four times each year and shall be subject to call by the chairperson or any two commission members at any time.”

SECTION 3. That all other terms and provisions of Ordinance No. 2012-36 not amended herein be, and the same is, hereby confirmed and ratified as if fully written herein.

SECTION 4. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees or subcommittees that resulted in those formal actions were in meetings open to the public in compliance with the law.


SECTION 5. That this Ordinance was adopted pursuant to Section 4.11, Charter, and is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety for the reason that said Commission makes decisions on issues on a monthly basis and the input of the additional Commission Members could make a difference in those decisions, and, pursuant to Section 4.13, Charter, shall take effect upon its adoption by Council and approval by the Mayor, otherwise at the earliest period allowed by law.
