The purpose for the Special Meeting is as follows:

AN ORDINANCE PROVIDING FOR A SEPARATE AMENDMENT TO THE CHARTER OF THE CITY OF STOW, OHIO, UNDER AUTHORITY OF SECTION 19.01, CHARTER, AS ORIGINALLY ADOPTED BY THE ELECTORATE ON NOVEMBER 4, 1958, AS AMENDED, TO BE SUBMITTED TO THE ELECTORATE AT THE GENERAL ELECTION ON NOVEMBER 5, 2019, TO AMEND SECTION 4.15, ENTITLED "COMPENSATION AND BONDS", OF ARTICLE IV, ENTITLED "THE COUNCIL", OF THE CITY OF STOW'S CHARTER BE CREATED TO REQUIRE SUBMITTAL TO THE ELECTORS OF THE CITY OF STOW FOR APPROVAL PRIOR INCREASING SALARIES OF ELECTED OFFICIALS.
